Purpose

Lorain County Public Health (LCPH) is offering Healthy Places grants to Lorain County organizations that aspire to build healthier communities through **built environment changes**.

The purpose of these grants is to create a **long-lasting impact** on the health of people in Lorain County, especially people in overburdened populations.

What is the built environment?

The physical characteristics of the communities in which people live, work and play.

- Parks and playgrounds
- Walking trails and sidewalks
- Public art and places to hang out
- Shared use spaces, like gyms
- Outdoor and public fitness equipment
- Community gardens





How does the built environment impact health?

- Promotes being active, eating healthy and other healthy habits;
- Encourages social connectedness;
- Prevents injuries and promote safety;
- Improves air, water and soil quality;
- Provides access to natural and green spaces;
- Ensures all members of the community have opportunities to be healthy regardless of their age, income level, gender, ethnic background, or any other social or economic reasons.



Overview of Grants

- A total of \$50,000 is available.
- Individual applicants can apply for up to \$10,000.
- LCPH will try to fund as many projects as possible.

Criteria for funding

- 1. Priority for funding goes to first-time grantees. Entities that have been previously awarded funding will be considered only after first-time grantees have been assessed.
- 2. Only projects in LCPH's jurisdiction are eligible to apply; this jurisdiction includes all of Lorain County with the exception of Vermillion.
- 3. Applicants must be a government agency or non-profit. Grants will not be awarded to individuals.

Award Details

- 1. Applicants must demonstrate partnership with at least one other entity.
- 2. Grants are awarded via reimbursement of funds. This means that the grantee pays for the equipment or service in the proposal, submits invoices, and then LCPH will pay the grantee that amount.
- 3. By November 30, 2024, final invoices are due to LCPH.
 - a. Grantee will receive reimbursement by February 15, 2025.

Unallowable Costs

Funds may not be used for:

- 1. Personnel costs.
 - a. This does not include contracted labor to install built environment changes, such as equipment installation, paving, painting, etc.
- 2. Food.
- 3. Bad debts of any kind.
- 4. Fundraising efforts.
- 5. Advancing political or religious points of view.
- 6. Costs to rent space.
- 7. Event sponsorships.

Project Requirements

- 1. Each grantee is required to complete one site visit.
 - a. The purpose of the visit is to track project progress.
- 2. Each grantee is required to complete an evaluation at the conclusion of their project
- Grantees give permission for LCPH to use and share photographs of grant funded projects, and to promote the grant through press releases and other media outlets.
- 4. Any publicity related to the grant funded project must be shared with and reviewed by LCPH during project implementation.
- 5. At any time, LCPH can discontinue funding with 30 days of written notice. At any time, grantees can end partnership with LCPH with 30 days of written notice. LCPH will issue a check to reimburse grantees for expenses up to the date of discontinuation.

How to apply

- 1. Application posted at LorainCountyHealth.com/healthygrants
- 2. All application materials must be filled out completely and must be **typed**.
 - a. LCPH will not accept handwritten applications.
 - b. LCPH may decline or defer incomplete applications to a different grant cycle.

Application deadline: February 19, 2024 at 11:59 p.m.

 - Get signature(s) and approval from your organization head.
 - ii. Letters of support from all listed partner agencies.
 - b. Project Overview
 - i. Goal
 - ii. Funds requested
 - iii. Descriptions

Connection to Community Health Improvement Plan: How does your project improve any of the following? If it does not, explain how it promotes the health of the community.

- Cancer prevention
- 2. Chronic disease (diabetes, heart disease, etc.) prevention
- 3. Health for moms and babies
- 4. Substance use disorder prevention and/or recovery
- 5. Mental health promotion

Project type - note all that apply (see Appendix II for examples).

- 1. Active transportation walkability, bikeability, and public transportation
- 2. Safe and inclusive places visibility and accessibility
- 3. Arts, culture, and placemaking
- 4. Physical activity, recreation, and trails
- 5. Nutrition and food systems

 - This can help us better understand your project and award partial funding.

Activity	Timeframe for completion	Person and agency responsible
Activity 1: Order equipment and supplies for the outdoor learning library space. Keep track of all invoices and bills.	May 2022	John Doe, Happytown Library
Activity 2: Prepare site and install outdoor learning equipment at Happytown Library. Take photos of complete work.	July 2022	Jane Smith, Rainbow City Engineer
Activity 3: Organize a ribbon cutting event and press release for the community to announce the library's new outdoor learning space.	August 2022	John Doe, Happytown Library
Activity 4: Organize, schedule, and promote after school activities in the library's new outdoor learning space. Recruit Scout volunteers to lead activities for younger children.	September - November 2022	Bill Johnson, Scouts
Activity 5: Monitor outdoor learning space for any additional needs. Keep the space clean and report repairs as needed to Rainbow City Engineers	July 2022 - Ongoing	John Doe, Happytown Library
